Funding bids were successful £6,000 from SNDC and £10,000 from Locality these funds will be used mainly in paying the consultants.

4 Discussion

The Vale – Difficulty in identifying a member for the Steering Group and this is ongoing, however, access to the Vale Management Group has been identified for the agenda and minutes so they are kept informed.

Housing Needs Assessment (HNA) – when applying for funding it was thought not to be required as Swainsthorpe has been designated as 'infill only' through the GNLP. To undertake a HNA will be extra funding through AECOM via Locality. (section Stage 2(a) of Consultant Programme of Work. Pro's and con's discussed and will discuss with Rachel Leggett and also gain an understanding of the design codes.

Parish Council Website – there is a Neighbourhood Plan item on the dropdown menu on the Swainsthorpe Parish Council website. However, we need a more prominent presence to fully engage with the community and could be part of an overall review of the website and how we can easily post items.

Neighbourhood Plan does it really affect planning decisions? – all the information from Locality and SNDC state that a Neighbourhood Plan must be considered during planning activities. It would have been useful during the recent Saving Swainsthorpe campaign - regarding which, it is possible to identify a view as an asset to the village, e.g. the view across the field from the A140 towards the Church.

Neighbourhood Plans and new Government – nothing as yet suggests any changes to Neighbourhood Plans (*since meeting EP read through current consultation on updating the National Planning Policy Framework and no mention of Neighbourhood Plans*)

Landowners & Businesses – must be approached and considered as part of the Neighbourhood Plan. Identifying who owns all the parcels of land surrounding the village will have to be undertaken. Businesses are mainly along Brick Kiln Lane, but also The Sugar Beat and garage on A140 and home workers?

Conflict of Interest – members working for SNDC and NCC concerned if this is a conflict, but reassured that if they felt an item directly related to their work they could absent themselves from the item under discussion.

Footpaths – concern regarding the encroaching electrical developments surrounding the village and the potential loss of amenity. Ensuring footpaths and green spaces are secure and identifying new ones will be integral to the
